Cost of Attendance

The Cost of Attendance (COA) is an estimate of the total amount of a student's educational expenses for their period of enrollment. This information is also used to set a limit on the amount of financial aid a student can receive during the academic year, per federal regulations. Students who have childcare or disability related expenses while attending SAM Tech may be eligible to add those expenses to their cost of attendance. Housing and Food, Transportation and Personal Expenses are average amounts based on an annual survey of our student body. These amounts will vary depending on the student's circumstances.
